SPECIFIC RATES FOR PROBATE CAPACITY:

Referral/Investigation and appointment of Probate	\$300
Annual/Final accounting Fee in Probate appointment	\$300

The above rates include any travel; meeting; obtaining necessary records (medical and/or financial); and preparation of reports and/or petitions; attendance to hearings excluding contested hearings.

SPECIFIC RATES MONTHLY ACTIVITY:

Accounting activities: The basic fees include, the involvement of the various staff (includes receipt of check(s), deposits, received billings, review, payment of debts, check costs, banking fees, posting, reconciliations, filing necessary taxes, mailing of weekly/monthly checks and other related accounting procedures)


- **Minimal accounting activity** **\$75 quarterly**
 - Special administrator of Trust accounts with minimal activity. Minimal activity includes: monitoring/securing the account; one deposit, three checks per month, reconciliation and revising budget once a year.
- **Medium accounting activity** **\$75 monthly**
 - Deposit of one to two income checks per month; under 10 checks per month, reconciliation and revising budget twice a year.
- **High accounting activity** **\$100 monthly**
 - Deposit of two or more income checks per month; over 10 checks per month, reconciliation and revising budget frequently to adjust to Ward's changing circumstances. Also includes purchasing additional phone minutes, deposit of checks to landlords or to Ward's debit card accounts.
